DOLOR, MPA, Ph.D., Provincial Governor hereinafter called the "ENTITY" and 876 CONSTRUCTION & SUPPLY with office address at Malamig, Calapan City, Oriental Mindoro represented by ROBERTO B. YLAGAN, Proprietor, hereinafter called the "CONTRACTOR".

WHEREAS, the ENTITY is desirous that the CONTRACTOR execute the Construction of Multi Purpose Covered Pavement (Covered Court) at Gloria Central School, Gloria, Oriental Mindoro, hereinafter called the "WORKS", and the ENTITY has accepted the Bid for the amount THREE MILLION ONE HUNDRED EIGHTY FOUR THOUSAND THREE HUNDRED FIFTY FOUR PESOS ONLY (Php 3,184,354.00) by the CONTRACTOR for the execution and completion of such Works and the remedying of any defects therein.
