DOLOR, MPA, Ph.D., Provincial Governor hereinafter called the "ENTITY" and MHARPHY CONSTRUCTION AND SUPPLY with office address at San Aquilino, Roxas, Oriental Mindoro represented by MARIO S. PEREZ, Proprietor, hereinafter called the "CONTRACTOR".
