CONTRACT AGREEMENT

THIS AGREEMENT, made this OCT 18 2021 between **PROVINCIAL GOVERNMENT OF ORIENTAL MINDORO**, Camilmil, Calapan City, Oriental Mindoro, represented by **HUMERLITO A. DOLOR, MPA, Ph.D.**, Provincial Governor hereinafter called the "ENTITY" and **MHARPHY CONSTRUCTION AND SUPPLY** with office address at San Aquilino, Roxas, Oriental Mindoro represented by **MARIO S. PEREZ**, Proprietor, hereinafter called the "CONTRACTOR".

**WHEREAS**, the ENTITY is desirous that the CONTRACTOR execute the **Concreting of Road at Maliwanag, Mansalay, Oriental Mindoro**, hereinafter called the "WORKS", and the ENTITY has accepted the Bid for the amount **ONE MILLION NINE HUNDRED EIGHTY EIGHT THOUSAND FOURTEEN PESOS AND 96/100 ONLY (Php 1,988,014.96)** by the CONTRACTOR for the execution and completion of such Works and the remedying of any defects therein.

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:
