OCT 2 1 2021 THIS AGREEMENT, made this between PROVINCIAL GOVERNMENT OF ORIENTAL MINDORO, Camilmil, Calapan City, Oriental Mindoro, represented by HUMERLITO A. DOLOR, MPA, Ph.D., Provincial Governor hereinafter and GEMWEALTH CONSTRUCTION AND the "ENTITY" CORPORATION with office address at Lapu-lapu, Ibaan, Batangas represented by CLYDE E. SOTTO, the Authorized Managing Officer, hereinafter called the "CONTRACTOR".

WHEREAS, the ENTITY is desirous that the CONTRACTOR execute the Improvement of Covered Court at Marfrancisco, Pinamalayan, Oriental Mindoro, hereinafter called the "WORKS", and the ENTITY has accepted the Bid for the amount ONE MILLION TWO HUNDRED SIXTY SIX THOUSAND TWO HUNDRED SIXTY SIX PESOS AND 20/100 ONLY (Php 1,266,266.20) by the CONTRACTOR for the execution and completion of such Works and the remedying of any defects therein.

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:
