CONTRACT AGREEMENT

THIS AGREEMENT, made this OCT 1 1 2021 between PROVINCIAL GOVERNMENT OF ORIENTAL MINDORO, Camilmil, Calapan City, Oriental Mindoro, represented by HUMERLITO A. DOLOR, MPA, Ph.D., Provincial Governor hereinafter called the "ENTITY" and ADL CONSTRAK with office address at Bagumbayan, Roxas, Oriental Mindoro represented by ALEX D. LAQUI, Authorized Managing Officer, hereinafter called the "CONTRACTOR".

WHEREAS, the ENTITY is desirous that the CONTRACTOR execute the Rehabilitation of Road at Papandayan, Pinamalayan, Oriental Mindoro, hereinafter called the "WORKS", and the ENTITY has accepted the Bid for the amount NINE HUNDRED SEVENTY SIX THOUSAND PESOS AND 47/100 ONLY (Php 976,000.47) by the CONTRACTOR for the execution and completion of such Works and the remedying of any defects therein.

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

 - E. Credit Line or Net Financial Contracting Capacity.
 - F. PERT/CPM Diagram and bar chart with S-curve.
 - G. Other documentary requirements

 - Manpower Utilization Schedule

 - 4. Construction Schedule and S-Curve
