CONTRACT AGREEMENT

THIS AGREEMENT, made this NOV 1 9 2021 between PROVINCIAL GOVERNMENT OF ORIENTAL MINDORO, Camilmil, Calapan City, Oriental Mindoro, represented by HUMERLITO A. DOLOR, MPA, Ph.D., Provincial Governor hereinafter called the "ENTITY" and 2332 BUILDERS with office address at Marang St., Camella Springville West Molino 3, Bacoor, Cavite represented by PEEJAY M. CLEMINO, Proprietress, hereinafter called the "CONTRACTOR".

WHEREAS, the ENTITY is desirous that the CONTRACTOR execute the Renovation of PISD Office at Provincial Capitol Complex, Calapan City, Oriental Mindoro, hereinafter called the "WORKS", and the ENTITY has accepted the Bid for the amount NINE HUNDRED SEVENTY NINE THOUSAND EIGHTY FIVE PESOS AND 68/100 ONLY (Php 979,085.68) by the CONTRACTOR for the execution and completion of such Works and the remedying of any defects therein.

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

 - E. Credit Line or Net Financial Contracting Capacity.
 - F. PERT/CPM Diagram and bar chart with S-curve.
