## CONTRACT AGREEMENT

THIS AGREEMENT, made this OCT 2 9 2021 between PROVINCIAL GOVERNMENT OF ORIENTAL MINDORO, Camilmil, Calapan City, Oriental Mindoro, represented by HUMERLITO A. DOLOR, MPA, Ph.D., Provincial Governor hereinafter called the "ENTITY" and CMSEL CONSTRUCTION AND DEVELOPER with office address at Masipit, Calapan City, Oriental Mindoro represented by MARIETA T. MADERAZO, Proprietress, hereinafter called the "CONTRACTOR".

WHEREAS, the ENTITY is desirous that the CONTRACTOR execute the Improvement of Ilaya- Bulusan Road at Ilaya, Calapan City, Oriental Mindoro, hereinafter called the "WORKS", and the ENTITY has accepted the Bid for the amount NINE HUNDRED EIGHTY ONE THOUSAND NINE HUNDRED ONE PESOS AND 89/100 ONLY (Php 981,901.89) by the CONTRACTOR for the execution and completion of such Works and the remedying of any defects therein.

## **NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:**
