DOLOR, MPA, Ph.D., Provincial Governor hereinafter called the "ENTITY" and LAS MINAS DE ORO CONSTRUCTION with office address in Sta. Maria Village, Calapan City, Oriental Mindoro represented by EVELYN A. ABAS, Proprietress, hereinafter called the "CONTRACTOR".

WHEREAS, the ENTITY is desirous that the CONTRACTOR execute the Concreting of Road at So. Camarin II, Biga, Calapan City, Oriental Mindoro. hereinafter called the "WORKS", and the ENTITY has accepted the Bid for the amount NINE HUNDRED NINETY ONE THOUSAND THREE HUNDRED EIGHTY THREE PESOS AND 61/100 ONLY (Php 991,383.61) by the CONTRACTOR for the execution and completion of such Works and the remedying of any defects therein.
