LOUIGI ALMOND P. GAYUTIN, Proprietor, hereinafter called the "CONTRACTOR".

WHEREAS, the ENTITY is desirous that the CONTRACTOR execute the Construction of Water System at Aurora, Naujan, Oriental Mindoro and Construction of Water System at Barcenaga, Naujan, Oriental Mindoro, hereinafter called the "WORKS", and the ENTITY has accepted the Bid for the amount NINE HUNDRED NINETY SIX THOUSAND THREE HUNDRED FORTY SIX PESOS ONLY (Php 996,346.00) by the CONTRACTOR for the execution and completion of such Works and the remedying of any defects therein.
