CONTRACT AGREEMENT

THIS AGREEMENT, made this NOV 12 2021 between PROVINCIAL GOVERNMENT OF ORIENTAL MINDORO, Camilmil, Calapan City, Oriental Mindoro, represented by HUMERLITO A. DOLOR, MPA, Ph.D., Provincial Governor hereinafter called the "ENTITY" and KASANGA CONSTRUCTION AND SUPPLIES with office address at Bayanan I, Calapan City, Oriental Mindoro represented by ROMEL B. DEINLA, General Manager, hereinafter called the "CONTRACTOR".

WHEREAS, the ENTITY is desirous that the CONTRACTOR execute the Improvement of Drainage Canal at San Vicente South, Calapan City, Oriental Mindoro, hereinafter called the "WORKS", and the ENTITY has accepted the Bid for the amount FOUR HUNDRED NINETY FIVE THOUSAND FOUR HUNDRED FOURTEEN PESOS AND 83/100 ONLY (Php 495,414.83) by the CONTRACTOR for the execution and completion of such Works and the remedying of any defects therein.

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:
