CONTRACT AGREEMENT

THIS AGREEMENT, made this NOV 05 2021 between PROVINCIAL GOVERNMENT OF ORIENTAL MINDORO, Camilmil, Calapan City, Oriental Mindoro, represented by HUMERLITO A. DOLOR, MPA, Ph.D., Provincial Governor hereinafter called the "ENTITY" and MG DRAGON CONSTRUCTION SERVICES with office address at Tawiran, Calapan City, Oriental Mindoro represented by MR. MARLON L. GOCO, the Authorized Managing Officer, hereinafter called the "CONTRACTOR".

WHEREAS, the ENTITY is desirous that the CONTRACTOR execute the Construction of Drainage Canal at Pinagkaisahan St., Karilagan St. A & B and Kaunlaran St., Camilmil, Calapan City, Oriental Mindoro, hereinafter called the "WORKS", and the ENTITY has accepted the Bid for the amount ONE MILLION EIGHT HUNDRED SIXTY EIGHT THOUSAND FORTY ONE PESOS AND 30/100 (Php 1,868,041.30) by the CONTRACTOR for the execution and completion of such Works and the remedying of any defects therein.

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:
