## **CONTRACT AGREEMENT**

THIS AGREEMENT, made this NOV 0 5 2021 between PROVINCIAL GOVERNMENT OF ORIENTAL MINDORO, Camilmil, Calapan City, Oriental Mindoro, represented by HUMERLITO A. DOLOR, MPA, Ph.D., Provincial Governor hereinafter called the "ENTITY" and DK CONSTRUCTION with office address at Barcenaga, Naujan, Oriental Mindoro represented by REGINO C. EVANGELISTA, Proprietor, hereinafter called the "CONTRACTOR".

WHEREAS, the ENTITY is desirous that the CONTRACTOR execute the Completion of Multi- Purpose Building at San Isidro, Naujan, Oriental Mindoro. hereinafter called the "WORKS", and the ENTITY has accepted the Bid for the amount ONE MILLION ONE HUNDRED TWENTY EIGHT THOUSAND THREE PESOS AND 25/100 ONLY (Php 1,128,003.25) by the CONTRACTOR for the execution and completion of such Works and the remedying of any defects therein.

## NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

- The Entity hereby covenants to pay the Contractor in consideration of the 4. execution and completion of the Works and the remedying of defects wherein, the Contract Price or such other sum as may become payable under the provisions of this Contract at the times and in the manner prescribed by this Contract.
