DOLOR, MPA, Ph.D., Provincial Governor hereinafter called the "ENTITY" and RJJJ ENGINEERING SERVICES with office address 030 Purok I, Brgy. San Agustin I, Naujan, Oriental Mindoro represented by JOHN CROMWELL D. RECTO, Proprietor, hereinafter called the "CONTRACTOR".

WHEREAS, the ENTITY is desirous that the CONTRACTOR execute the Completion of Gymnasium at San Agustin NHS, San Agustin II, Naujan, Oriental Mindoro, hereinafter called the "WORKS", and the ENTITY has accepted the Bid for the amount ONE MILLION NINE HUNDRED EIGHTY FIVE THOUSAND NINE HUNDRED EIGHTY FOUR PESOS AND 91/100 ONLY (Php 1,985,984.91) by the CONTRACTOR for the execution and completion of such Works and the remedying of any defects therein.

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:
