THIS AGREEMENT, made this NOV 05 2021 between PROVINCIAL GOVERNMENT OF ORIENTAL MINDORO, Camilmil, Calapan City, Oriental Mindoro, represented by HUMERLITO A. DOLOR, MPA, Ph.D., Provincial Governor hereinafter called the "ENTITY" and MARCPHIL CONSTRUCTION with office address at San Aquilino, Roxas, Oriental Mindoro represented by MARCIANO M. DIMAPILIS, Proprietor, hereinafter called the "CONTRACTOR".

WHEREAS, the ENTITY is desirous that the CONTRACTOR execute the Expansion of Agri Processing Center at Provincial Demo Farm, Merit, Victoria, Oriental Mindoro, hereinafter called the "WORKS", and the ENTITY has accepted the Bid for the amount THREE MILLION NINE HUNDRED SIXTY SIX THOUSAND THREE HUNDRED SIXTY NINE PESOS AND 10/100 ONLY (Php 3,966,369.10) by the CONTRACTOR for the execution and completion of such Works and the remedying of any defects therein.
