CONTRACT AGREEMENT

THIS AGREEMENT, made this NOV 05 2021 between PROVINCIAL GOVERNMENT OF ORIENTAL MINDORO, Camilmil, Calapan City, Oriental Mindoro, represented by HUMERLITO A. DOLOR, MPA, Ph.D., Provincial Governor hereinafter called the "ENTITY" and CMSEL CONSTRUCTION AND DEVELOPER with office address at Masipit, Calapan City, Oriental Mindoro represented by MARIETA T. MADERAZO, Proprietress, hereinafter called the "CONTRACTOR".

WHEREAS, the ENTITY is desirous that the CONTRACTOR execute the Construction of 1 Classroom Building at Victoria National High School, Poblacion I, Victoria, Oriental Mindoro and Construction of Covered Pathwalk at Bayuin NHS, Socorro, Oriental Mindoro, hereinafter called the "WORKS", and the ENTITY has accepted the Bid for the amount ONE MILLION SIX HUNDRED SEVENTY THREE THOUSAND NINE PESOS AND 70/100 ONLY (Php 1,673,009.70) by the CONTRACTOR for the execution and completion of such Works and the remedying of any defects therein.

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:
