CONTRACT AGREEMENT

THIS AGREEMENT, made this NOV 05 2021 between PROVINCIAL GOVERNMENT OF ORIENTAL MINDORO, Camilmil, Calapan City, Oriental Mindoro, represented by HUMERLITO A. DOLOR, MPA, Ph.D., Provincial Governor hereinafter called the "ENTITY" and MDH CONSTRUCTION with office address at #327 College Road, Brgy. 58, Pasay City, Metro Manila represented by ARCHIE LEE HUEVOS, General Manager, hereinafter called the "CONTRACTOR".

WHEREAS, the ENTITY is desirous that the CONTRACTOR execute the Rehabilitation/ Upgrading of Road at Poblacion I, Victoria, Oriental Mindoro, hereinafter called the "WORKS", and the ENTITY has accepted the Bid for the amount THREE MILLION FOUR HUNDRED NINETY ONE THOUSAND FOUR HUNDRED TWENTY THREE PESOS AND 92/100 ONLY (Php 3,491,423.92) by the CONTRACTOR for the execution and completion of such Works and the remedying of any defects therein.

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:
