CONTRACT AGREEMENT

THIS AGREEMENT, made this NOV 19 2021 between PROVINCIAL GOVERNMENT OF ORIENTAL MINDORO, Camilmil, Calapan City, Oriental Mindoro, represented by HUMERLITO A. DOLOR, MPA, Ph.D., Provincial Governor hereinafter called the "ENTITY" and 2332 BUILDERS with office address at Marang St., Camella Springville West Molino 3, Baco, Cavite represented by PEEJAY M. CLEMINO, Proprietress, hereinafter called the "CONTRACTOR".

WHEREAS, the ENTITY is desirous that the CONTRACTOR execute the Concreting of Road at San Ignacio, Baco, Oriental Mindoro, hereinafter called the "WORKS", and the ENTITY has accepted the Bid for the amount NINE HUNDRED EIGHTY TWO THOUSAND FIVE HUNDRED SEVENTY ONE PESOS AND 99/100 ONLY (Php 982,571.99) by the CONTRACTOR for the execution and completion of such Works and the remedying of any defects therein.

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:
