CONTRACT AGREEMENT

THIS AGREEMENT, made this NOV 1 9 2021 between PROVINCIAL GOVERNMENT OF ORIENTAL MINDORO, Camilmil, Calapan City, Oriental Mindoro, represented by HUMERLITO A. DOLOR, MPA, Ph.D., Provincial Governor hereinafter called the "ENTITY" and 2332 BUILDERS with office address at Marang St., Camella Springville West Molino 3, Bacoor, Cavite represented by PEEJAY M. CLEMINO, Proprietress, hereinafter called the "CONTRACTOR".

WHEREAS, the ENTITY is desirous that the CONTRACTOR execute the Concreting of Road at Lantuyang, Baco, Oriental Mindoro, hereinafter called the "WORKS", and the ENTITY has accepted the Bid for the amount NINE HUNDRED EIGHTY ONE THOUSAND NINE HUNDRED SIX PESOS AND 92/100 ONLY (Php 981,906.92) by the CONTRACTOR for the execution and completion of such Works and the remedying of any defects therein.

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:
