CONTRACT AGREEMENT

THIS AGREEMENT, made this OCT 29 2021 between **PROVINCIAL GOVERNMENT OF ORIENTAL MINDORO**, Camilmil, Calapan City, Oriental Mindoro, represented by **HUMERLITO A. DOLOR, MPA, Ph.D.**, Provincial Governor hereinafter called the "ENTITY" and **RADEL CONSTRUCTION** with office address along C-5 Road, Sta. Isabel, Calapan City, Oriental Mindoro represented by **ENGR. ADELFA P. PEREZ**, Proprietress, hereinafter called the "CONTRACTOR".

WHEREAS, the ENTITY is desirous that the CONTRACTOR execute the **Concreting of Road Gap at Barangay Calangatan, San Teodoro, Oriental Mindoro**, hereinafter called the "WORKS", and the ENTITY has accepted the Bid for the amount **NINE HUNDRED EIGHTY THREE THOUSAND TWO HUNDRED SIXTY EIGHT PESOS AND 38/100 ONLY (Php 983,268.38)** by the CONTRACTOR for the execution and completion of such Works and the remedying of any defects therein.

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:
