CONTRACT AGREEMENT

THIS AGREEMENT, made this OCT 2 9 2021 between PROVINCIAL GOVERNMENT OF ORIENTAL MINDORO, Camilmil, Calapan City, Oriental Mindoro, represented by HUMERLITO A. DOLOR, MPA, Ph.D., Provincial Governor hereinafter called the "ENTITY" and RADEL CONSTRUCTION with office address along C-5 Road. Sta. Isabel, Calapan City, Oriental Mindoro represented by ENGR. ADELFA P. PEREZ, Proprietress, hereinafter called the "CONTRACTOR".

WHEREAS, the ENTITY is desirous that the CONTRACTOR execute the Concreting of Road Gap at Barangay Calangatan, San Teodoro, Oriental Mindoro, hereinafter called the "WORKS", and the ENTITY has accepted the Bid for the amount NINE HUNDRED EIGHTY THREE THOUSAND TWO HUNDRED SIXTY EIGHT PESOS AND 38/100 ONLY (Php 983,268.38) by the CONTRACTOR for the execution and completion of such Works and the remedying of any defects therein.
