NOV 1 6 2021 THIS AGREEMENT, made this between PROVINCIAL GOVERNMENT OF ORIENTAL MINDORO, Camilmil, Calapan City, Oriental Mindoro, represented by HUMERLITO A. DOLOR, MPA, Ph.D., Provincial Governor hereinafter called the "ENTITY" and WTL CONSTRUCTION with office address Manilo St., Mansalay, Oriental Mindoro represented by RENATO T. DE LARA, Proprietor, hereinafter called the "CONTRACTOR".

WHEREAS, the ENTITY is desirous that the CONTRACTOR execute the Construction of Water System at San Juan, Bulalacao, Oriental Mindoro, hereinafter called the "WORKS", and the ENTITY has accepted the Bid for the amount NINE HUNDRED NINETY THOUSAND FIFTY SEVEN PESOS AND 12/100 (Php 990,057,12) by the CONTRACTOR for the execution and completion of such Works and the remedying of any defects therein.
