CONTRACT AGREEMENT

THIS AGREEMENT, made this DEC 03 2021 between PROVINCIAL GOVERNMENT OF ORIENTAL MINDORO, Camilmil, Calapan City, Oriental Mindoro, represented by HUMERLITO A. DOLOR, MPA, Ph.D., Provincial Governor hereinafter called the "ENTITY" and F.S SUGAY CONSTRUCTION & SUPPLIES with office address in Mahogany St. Sto. Niño, Calapan City, Oriental Mindoro represented by FRANCILITA S. SUGAY, Proprietress, hereinafter called the "CONTRACTOR".

WHEREAS, the ENTITY is desirous that the CONTRACTOR execute the Concreting of Road going to CVHS-Bayanan Campus at Bayanan II, Calapan City, Oriental Mindoro, hereinafter called the "WORKS", and the ENTITY has accepted the Bid for the amount NINE HUNDRED NINETY TWO THOUSAND FIVE HUNDRED FIFTY TWO PESOS AND 25/100 ONLY (Php 992,552.25) by the CONTRACTOR for the execution and completion of such Works and the remedying of any defects therein.
