CONTRACT AGREEMENT

THIS AGREEMENT, made this NOV 16 2021 between PROVINCIAL GOVERNMENT OF ORIENTAL MINDORO, Camilmil, Calapan City, Oriental Mindoro, represented by HUMERLITO A. DOLOR, MPA, Ph.D., Provincial Governor hereinafter called the "ENTITY" and B5 BUILDERS & SUPPLIES with office address at Libis, Calapan City, Oriental Mindoro represented by BERNARDO O. APACIBLE, Proprietor, hereinafter called the "CONTRACTOR".

WHEREAS, the ENTITY is desirous that the CONTRACTOR execute the Concreting of FMR at So. Riverside, Catuwiran I, Baco, Oriental Mindoro, hereinafter called the "WORKS", and the ENTITY has accepted the Bid for the amount NINE HUNDRED EIGHTY THREE THOUSAND EIGHT HUNDRED FIFTY NINE PESOS AND 82/100 ONLY (Php 983,859.82) by the CONTRACTOR for the execution and completion of such Works and the remedying of any defects therein.

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:
