CONTRACT AGREEMENT

THIS AGREEMENT, made this NOV 12 2021 between PROVINCIAL GOVERNMENT OF ORIENTAL MINDORO, Camilmil, Calapan City, Oriental Mindoro, represented by HUMERLITO A. DOLOR, MPA, Ph.D., Provincial Governor hereinafter called the "ENTITY" and WINKONSTRACT ENTERPRISES with office address at Unit 17, Filipiniana Complex, Calapan City, Oriental Mindoro represented by ENGR. LOUIGI ALMOND P. GAYUTIN, Proprietor, hereinafter called the "CONTRACTOR".

WHEREAS, the ENTITY is desirous that the CONTRACTOR execute the Concreting of Road at Sitio Pagkakaisa, Brgy. Lucio Laurel, Gloria, Oriental Mindoro, hereinafter called the "WORKS", and the ENTITY has accepted the Bid for the amount NINE HUNDRED FIFTY EIGHT THOUSAND FOUR HUNDRED TWENTY FOUR PESOS AND 29/100 ONLY (Php 958,424.29) by the CONTRACTOR for the execution and completion of such Works and the remedying of any defects therein.

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:
