CONTRACT AGREEMENT

THIS AGREEMENT, made this NOV 09 2021 between **PROVINCIAL GOVERNMENT OF ORIENTAL MINDORO**, Camilmil, Calapan City, Oriental Mindoro, represented by **HUMERLITO A. DOLOR, MPA, Ph.D.**, Provincial Governor hereinafter called the "ENTITY" and **811 TRADING AND CONSTRUCTION** with office address at 9 Palayan St., Paclasan, Roxas, Oriental Mindoro represented by **ENGR. ARMIN C. SUZARA**, Proprietor, hereinafter called the "CONTRACTOR".

WHEREAS, the ENTITY is desirous that the CONTRACTOR execute the **Concreting of Rosario-Maningcol Road at Rosario, Pinamalayan, Oriental Mindoro**, hereinafter called the "WORKS", and the ENTITY has accepted the Bid for the amount **NINE HUNDRED NINETY TWO THOUSAND TWO HUNDRED THIRTY TWO PESOS AND 28/100 ONLY (Php 992,232.28)** by the CONTRACTOR for the execution and completion of such Works and the remedying of any defects therein.

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:
