DOLOR, MPA, Ph.D., Provincial Governor hereinafter called the "ENTITY" and F.S SUGAY CONSTRUCTION & SUPPLIES with office address in Mahogany St. Sto. Niño, Calapan City, Oriental Mindoro represented by FRANCILITA S. SUGAY, Proprietress, hereinafter called the "CONTRACTOR".

WHEREAS, the ENTITY is desirous that the CONTRACTOR execute the Concreting of Road at Mangangan I, Baco, Oriental Mindoro, hereinafter called the "WORKS", and the ENTITY has accepted the Bid for the amount NINE HUNDRED EIGHTY THOUSAND SEVEN HUNDRED THREE PESOS AND 88/100 ONLY (Php 980,703.88) by the CONTRACTOR for the execution and completion of such Works and the remedying of any defects therein.

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:
