CONTRACT AGREEMENT

THIS AGREEMENT, made this DEC 03 2021 between **PROVINCIAL GOVERNMENT OF ORIENTAL MINDORO**, Camilmil, Calapan City, Oriental Mindoro, represented by **HUMERLITO A. DOLOR, MPA, Ph.D.**, Provincial Governor hereinafter called the "ENTITY" and **NAMNAMA CONSTRUCTION SUPPLIES** with office address at San Mariano, Roxas, Oriental Mindoro represented by **REYNALDO C. GARABILES**, Proprietor, hereinafter called the "CONTRACTOR".

WHEREAS, the ENTITY is desirous that the CONTRACTOR execute the **Concreting of Road at Labasan, Bongabong, Oriental Mindoro**, hereinafter called the "WORKS", and the ENTITY has accepted the Bid for the amount **THREE HUNDRED FIFTY SEVEN THOUSAND FIVE HUNDRED FIFTY TWO PESOS AND 34/100 ONLY (Php 357,552.34)** by the CONTRACTOR for the execution and completion of such Works and the remedying of any defects therein.

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:
