Completion of Multi-Purpose Building at Malvar, Naujan, Oriental Mindoro

- 1. The Provincial Government of Oriental Mindoro (PGOM) through the 20% Development Fund 2021 intends to apply the sum of Two Hundred Thirty Five thousand Seven Hundred Seventy Five Pesos and 39/100 Only (Php 235,775.39) being the approved Budget for the Contract (ABC) to payment under the contract for "Completion of Multi-Purpose Building at Malvar, Naujan, Or. Mindoro". Bids received in excess of the ABC shall be automatically rejected at bid opening.
- 2. The PGOM now invites bids for "Completion of Multi-Purpose Building at Malvar, Naujan, Or. Mindoro". Completion of the Works is 15 calendar days. Bidders should have completed within five (5) years before the date of submission and receipt of bids, a single completed contract similar to the Project worth at least fifty percent (50%) of the ABC. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.
