CONTRACT AGREEMENT

THIS AGREEMENT, made this NOV 09 2021 between **PROVINCIAL GOVERNMENT OF ORIENTAL MINDORO**, Camilmil, Calapan City, Oriental Mindoro, represented by **HUMERLITO A. DOLOR, MPA, Ph.D.**, Provincial Governor hereinafter called the "ENTITY" and **GREAT SWISS METAL BUILDERS CORP.** with office address at 2nd Floor, Great Swiss Metal Builders Building, Batangas City represented by **ENGR. VICENTE I. CANTOS**, President/CEO, hereinafter called the "CONTRACTOR".

WHEREAS, the ENTITY is desirous that the CONTRACTOR execute the **Completion of Barangay Hall at Biga, Calapan City, Oriental Mindoro**, hereinafter called the "WORKS", and the ENTITY has accepted the Bid for the amount **TWO HUNDRED NINETY THOUSAND FIVE HUNDRED THIRTY SEVEN PESOS AND 09/100 ONLY (Php 290,537.09)** by the CONTRACTOR for the execution and completion of such Works and the remedying of any defects therein.

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:
