CONTRACT AGREEMENT

THIS AGREEMENT, made this NOV 0 9 2021 between PROVINCIAL GOVERNMENT OF ORIENTAL MINDORO, Camilmil, Calapan City, Oriental Mindoro, represented by HUMERLITO A. DOLOR, MPA, Ph.D., Provincial Governor hereinafter called the "ENTITY" and GREAT SWISS METAL BUILDERS CORP. with office address at 2nd Floor, Great Swiss Metal Builders Building, Batangas City represented by ENGR. VICENTE I. CANTOS, President/CEO, hereinafter called the "CONTRACTOR".

WHEREAS, the ENTITY is desirous that the CONTRACTOR execute the Completion of Barangay Hall at Biga, Calapan City, Oriental Mindoro, hereinafter called the "WORKS", and the ENTITY has accepted the Bid for the amount TWO HUNDRED NINETY THOUSAND FIVE HUNDRED THIRTY SEVEN PESOS AND 09/100 ONLY (Php 290,537.09) by the CONTRACTOR for the execution and completion of such Works and the remedying of any defects therein.

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:
