

CONTRACT AGREEMENT

THIS AGREEMENT, made this DEC 1 0 2021 between PROVINCIAL GOVERNMENT OF ORIENTAL MINDORO, Camilmil, Calapan City, Oriental Mindoro, represented by HUMERLITO A. DOLOR, MPA, Ph.D., Provincial Governor hereinafter called the "ENTITY" and F.S SUGAY CONSTRUCTION & SUPPLIES with office address in Mahogany St. Sto. Niño, Calapan City, Oriental Mindoro represented by FRANCILITA S. SUGAY, Proprietress, hereinafter called the "CONTRACTOR".

WHEREAS, the ENTITY is desirous that the CONTRACTOR execute the Concreting of Road at Tabon-Tabon, Baco, Oriental Mindoro, hereinafter called the "WORKS", and the ENTITY has accepted the Bid for the amount NINE HUNDRED EIGHTY FOUR THOUSAND ONE HUNDRED TWENTY SEVEN PESOS AND 18/100 ONLY (Php 984,127.18) by the CONTRACTOR for the execution and completion of such Works and the remedying of any defects therein.

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

 - E. Credit Line or Net Financial Contracting Capacity.
 - F. PERT/ CPM Diagram and bar chart with S-curve.
 - G. Other documentary requirements
 - 1. Equipment Utilization Schedule
 - 2. Manpower Utilization Schedule
 - 3. Construction Method
 - 4. Construction Schedule and S-Curve
