CONTRACT AGREEMENT

THIS AGREEMENT, made this DEC 14 2021 between PROVINCIAL GOVERNMENT OF ORIENTAL MINDORO, Camilmil, Calapan City, Oriental Mindoro, represented by HUMERLITO A. DOLOR, MPA, Ph.D., Provincial Governor hereinafter called the "ENTITY" and DELROL ENTERPRISES with office address at Poblacion, Baco, Oriental Mindoro represented by ALLAN A. ROLDAN, Proprietor, hereinafter called the "CONTRACTOR".

WHEREAS, the ENTITY is desirous that the CONTRACTOR execute the Concreting of Road at Burbuli, Baco, Oriental Mindoro, hereinafter called the "WORKS", and the ENTITY has accepted the Bid for the amount NINE HUNDRED NINETY FOUR THOUSAND TWO HUNDRED TWENTY SEVEN PESOS AND 39/100 (Php 994,227.39) by the CONTRACTOR for the execution and completion of such Works and the remedying of any defects therein.
