LOUIGI ALMOND P. GAYUTIN, Proprietor, hereinafter called the "CONTRACTOR".

WHEREAS, the ENTITY is desirous that the CONTRACTOR execute the Concreting of Road at Catuwiran II, Baco, Oriental Mindoro, hereinafter called the "WORKS", and the ENTITY has accepted the Bid for the amount NINE HUNDRED EIGHTY TWO THOUSAND NINE HUNDRED THIRTY PESOS AND 85/100 ONLY (Php 982,930.85) by the CONTRACTOR for the execution and completion of such Works and the remedying of any defects therein.
