CONTRACT AGREEMENT

THIS AGREEMENT, made this NOV 2 3 2021 between PROVINCIAL GOVERNMENT OF ORIENTAL MINDORO, Camilmil, Calapan City, Oriental Mindoro, represented by HUMERLITO A. DOLOR, MPA, Ph.D., Provincial Governor hereinafter called the "ENTITY" and AIDFELART CONST. CORP. with office at San Aquilino, Roxas, Oriental Mindoro represented by ENGR. AIDA G. MALUBAY, President/ General Manager, hereinafter called the "CONTRACTOR".

WHEREAS, the ENTITY is desirous that the CONTRACTOR execute the Concreting of Road at Sitio Riverside, Brgy. San Isidro, Roxas, Oriental Mindoro, hereinafter called the "WORKS", and the ENTITY has accepted the Bid for the amount NINE HUNDRED NINETY THREE THOUSAND FOUR HUNDRED THIRTY SIX PESOS AND 73/100 ONLY (Php 993,436.73) by the CONTRACTOR for the execution and completion of such Works and the remedying of any defects therein.

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:
