CONTRACT AGREEMENT

THIS AGREEMENT, made this NOV 19 2021 between PROVINCIAL GOVERNMENT OF ORIENTAL MINDORO, Camilmil, Calapan City, Oriental Mindoro, represented by HUMERLITO A. DOLOR, MPA, Ph.D., Provincial Governor hereinafter called the "ENTITY" and SGDG CONSTRUCTION AND SUPPLIES with office address Sapul, Calapan City, Oriental Mindoro represented by DEMETRIUS H. GOZAR, Proprietor, hereinafter called the "CONTRACTOR".

WHEREAS, the ENTITY is desirous that the CONTRACTOR execute the Concreting of Road at Dulangan, Puerto Galera, Oriental Mindoro, hereinafter called the "WORKS", and the ENTITY has accepted the Bid for the amount NINE HUNDRED NINETY THREE THOUSAND EIGHT HUNDRED ELEVEN PESOS AND 51/100 ONLY (Php 993,811.51) by the CONTRACTOR for the execution and completion of such Works and the remedying of any defects therein.

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:
