**BAC RESOLUTION DECLARING SINGLE CALCULATED RESPONSIVE BID (SCRB) AND  
RECOMMENDING APPROVAL OF AWARD OF THE CONTRACT  
(INFRASTRUCTURE)**

**Resolution No. 472, Series of 2021**

**WHEREAS**, there is an infrastructure project funded through the **LGSF-DRRP Fund 2021** to be undertaken by the Provincial Government of Oriental Mindoro for the **Repair of 1 CL in San Jose ES, Roxas, Oriental Mindoro and Repair of 3 CL in Mansalay CS, Mansalay, Oriental Mindoro (Repair of Roofing & Ceiling; Repair of Roofing & Ceiling);**

**WHEREAS**, the Provincial Government of Oriental Mindoro thru its Bids and Awards Committee advertised the Notice of Invitation to Bid (IB No. CW-2021-451) in PhilGEPS Website on **October 18, 2021** and posted in the Provincial Capitol Complex, Bulletin Board, Camilmil, Calapan City on even date for the **Repair of 1 CL in San Jose ES, Roxas, Oriental Mindoro and Repair of 3 CL in Mansalay CS, Mansalay, Oriental Mindoro (Repair of Roofing & Ceiling; Repair of Roofing & Ceiling);**

**WHEREAS**, in response to the said advertisement, **one (1) prospective bidder/contractor** submitted application for eligibility and purchased bid documents;

**1. RM SESCAR ENTERPRISES**

**WHEREAS**, the opening of bid was held at BAC Office, Provincial Capitol Complex, Calapan City on **October 27, 2021**, the bids were received until **8:30 am** and opened thereafter in accordance with the provisions of **R.A. 9184** otherwise known as "**Government Procurement Reform Act and its Implementing Rules and Regulations**";

**WHEREAS**, during the opening of Bid on **October 27, 2021** eligibility check was conducted to one bidder/contractor mentioned above and were found eligible by the BAC;

**WHEREAS**, the bid proposals submitted by **RM SESCAR ENTERPRISES** was examined and found substantially complied with the technical and financial proposals, thereby making the bid proposals passed the preliminary examination of bid as the bid price read out as:
