CARVAJAL, Proprietor, hereinafter called the "CONTRACTOR".

WHEREAS, the ENTITY is desirous that the CONTRACTOR execute the Construction of Perimeter Fence and Gate at Bongabong Technical & Vocational High School at Poblacion, Bongabong, Oriental Mindoro, hereinafter called the "WORKS", and the ENTITY has accepted the Bid for the amount FOUR HUNDRED NINETY FOUR THOUSAND FIFTY EIGHT PESOS AND 50/100 ONLY (Php 494,058.50) by the CONTRACTOR for the execution and completion of such Works and the remedying of any defects therein.
