CONTRACT AGREEMENT

THIS AGREEMENT, made this NOV 19 2021 between PROVINCIAL GOVERNMENT OF ORIENTAL MINDORO, Camilmil, Calapan City, Oriental Mindoro, represented by HUMERLITO A. DOLOR, MPA, Ph.D., Provincial Governor hereinafter called the "ENTITY" and WEBUILD CONSTRUCTION with office address at Bagumbayan, Roxas, Oriental Mindoro represented by CHRISTOPHER Y. CARVAJAL, Proprietor, hereinafter called the "CONTRACTOR".

WHEREAS, the ENTITY is desirous that the CONTRACTOR execute the Construction of Perimeter Fence and Gate at Bongabong Technical & Vocational High School at Poblacion, Bongabong, Oriental Mindoro, hereinafter called the "WORKS", and the ENTITY has accepted the Bid for the amount FOUR HUNDRED NINETY FOUR THOUSAND FIFTY EIGHT PESOS AND 50/100 ONLY (Php 494,058.50) by the CONTRACTOR for the execution and completion of such Works and the remedying of any defects therein.

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:
