CONTRACT AGREEMENT

NOV 2 3 2021 THIS AGREEMENT, made this between PROVINCIAL GOVERNMENT OF ORIENTAL MINDORO, Camilmil, Calapan City, Oriental Mindoro, represented by HUMERLITO A. DOLOR, MPA, Ph.D., Provincial Governor hereinafter called the "ENTITY" and WINKONSTRACT ENTERPRISES with office address at Unit 17. Filipiniana Complex, Calapan City, Oriental Mindoro represented by ENGR. LOUIGI ALMOND P. GAYUTIN, Proprietor, hereinafter called the "CONTRACTOR".

WHEREAS, the ENTITY is desirous that the CONTRACTOR execute the Repair of Railing of Footbridge at San Antonio, Naujan, Oriental Mindoro, hereinafter called the "WORKS", and the ENTITY has accepted the Bid for the amount FOUR HUNDRED NINETY SIX THOUSAND EIGHT HUNDRED THREE PESOS AND 27/100 ONLY (Php 496,803.27) by the CONTRACTOR for the execution and completion of such Works and the remedying of any defects therein.

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:
