Concreting of Road at Uyao, Roxas, Oriental Mindoro

- 1. The Provincial Government of Oriental Mindoro (PGOM) through the 20% Development Fund 2021 intends to apply the sum of One Million Four Hundred Ninety Three Thousand Two Hundred Eleven Pesos and 12/100 Only (Php 1,493,211.12) being the approved Budget for the Contract (ABC) to payment under the contract for "Concreting of Road at Uyao, Roxas, Oriental Mindoro". Bids received in excess of the ABC shall be automatically rejected at bid opening.
- 2. The PGOM now invites bids for "Concreting of Road at Uyao, Roxas, Oriental Mindoro". Completion of the Works is 50 calendar days. Bidders should have completed within five (5) years before the date of submission and receipt of bids, a single completed contract similar to the Project worth at least fifty percent (50%) of the ABC.
