DOLOR, MPA, Ph.D., Provincial Governor hereinafter called the "ENTITY" and MHARPHY CONSTRUCTION AND SUPPLY with office address at San Aquilino, Roxas, Oriental Mindoro represented by MARIO S. PEREZ, Proprietor, hereinafter called the "CONTRACTOR".

WHEREAS, the ENTITY is desirous that the CONTRACTOR execute the Concreting of Carmundo- Tawas Road at Carmundo, Bongabong, Oriental Mindoro, hereinafter called the "WORKS", and the ENTITY has accepted the Bid for the amount TWO MILLION FOUR HUNDRED SEVENTY SIX THOUSAND NINE HUNDRED SEVENTEEN PESOS AND 62/100 ONLY (Php 2,476,917.62) by the CONTRACTOR for the execution and completion of such Works and the remedying of any defects therein.
