Construction of Health Center at Poblacion, Bulalacao, Or. Mindoro

- 1. The Provincial Government of Oriental Mindoro (PGOM) through the LGSF-DRRP 2021 intends to apply the sum of One Million Three Hundred Eighty Three Thousand Four Hundred Forty Eight Pesos and 69/100 Only (Php 1,383,448.69), being the approved Budget for the Contract (ABC) to payment under the contract for "Construction of Health Center at Poblacion, Bulalacao, Or. Mindoro". Bids received in excess of the ABC shall be automatically rejected at bid opening.
- 2. The PGOM now invites bids for "Construction of Health Center at Poblacion, Bulalacao, Or. Mindoro". Completion of the Works is 67 calendar days. Bidders should have completed within five (5) years before the date of submission and receipt of bids, a single completed contract similar to the Project worth at least fifty percent (50%) of the ABC. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.
