CONTRACT AGREEMENT

DOLOR, MPA, Ph.D., Provincial Governor hereinafter called the "ENTITY" and RJJJ ENGINEERING SERVICES with office address 030 Purok I, Brgy. San Agustin I, Naujan, Oriental Mindoro represented by JOHN CROMWELL D. **RECTO**, Proprietor, hereinafter called the "CONTRACTOR".

WHEREAS, the ENTITY is desirous that the CONTRACTOR execute the Construction of Slope Protection at Melgar B, Naujan, Oriental Mindoro, hereinafter called the "WORKS", and the ENTITY has accepted the Bid for the amount THREE MILLION NINE HUNDRED FORTY NINE THOUSAND EIGHT HUNDRED FORTY TWO PESOS AND 74/100 (Php 3,949,842.74) by the CONTRACTOR for the execution and completion of such Works and the remedying of any defects therein.

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:
