# BAC RESOLUTION DECLARING SINGLE CALCULATED RESPONSIVE BID (SCRB) AND RECOMMENDING APPROVAL OF AWARD OF THE CONTRACT (INFRASTRUCTURE)

### Resolution No. 496, Series of 2021

WHEREAS, there is an infrastructure project funded through the 20% Development Fund 2021 to be undertaken by the Provincial Government of Oriental Mindoro for the Concreting of Road at Formon, Bongabong, Oriental Mindoro (Concreting of Road: PCCP: L of PCCP=220.00m; W of PCCP=4.00m; T of PCCP=0.23m; Thk 201=0.20; SHOULDER: Width BW=0.50);

WHEREAS, the Provincial Government of Oriental Mindoro thru its Bids and Awards Committee advertised the Notice of Invitation to Bid (IB No. CW-2021-478) in PhilGEPS Website on October 08, 2021 and posted in the Provincial Capitol Complex, Bulletin Board, Camilmil, Calapan City on even date for the Concreting of Road at Formon, Bongabong, Oriental Mindoro (Concreting of Road: PCCP: L of PCCP=220.00m; W of PCCP=4.00m; T of PCCP=0.23m; Thk 201=0.20; SHOULDER: Width BW=0.50);

WHEREAS, in response to the said advertisement, one (1) prospective bidder/contractor submitted application for eligibility and purchased bid documents;

#### 1. MARCPHIL CONSTRUCTION

WHEREAS, the opening of bid was held at BAC Office, Provincial Capitol Complex, Calapan City on October 29, 2021, the bids were received until 8:30 am and opened thereafter in accordance with the provisions of R.A. 9184 otherwise known as "Government Procurement Reform Act and its Implementing Rules and Regulations";

WHEREAS, during the opening of Bid on October 29, 2021 eligibility check was conducted to one bidder/contractor mentioned above and were found eligible by the BAC;

WHEREAS, the bid proposals submitted by MARCPHIL CONSTRUCTION was examined and found substantially complied with the technical and financial proposals, thereby making the bid proposals passed the preliminary examination of bid as the bid price read out as:

WHEREAS, the detailed evaluation of bids conducted on October 29, 2021 found out that bid price of MARCPHIL CONSTRUCTION is deemed the most advantageous to the government and no minor arithmetic correction has been made and therefore, found to be the Single Calculated Bid;

WHEREAS, upon careful examination, validation and verification of eligibility, technical, financial requirements submitted by MARCPHIL CONSTRUCTION with Single Calculated Bid, its bid passed the post qualification process conducted on November 03, 2021, thereby making its bid found to be responsive;
