**BAC RESOLUTION DECLARING LOWEST CALCULATED RESPONSIVE BID (LCRB) AND  
RECOMMENDING APPROVAL OF AWARD OF THE CONTRACT  
(INFRASTRUCTURE)**

**Resolution No. 502, Series of 2021**

**WHEREAS**, there is an infrastructure project funded through the **20% Development Fund 2021** to be undertaken by the Provincial Government of Oriental Mindoro for the **Concreting of Road at Herrera, Naujan, Oriental Mindoro (Concreting of Road: PCCP: L of PCCP=68.00m, W of PCCP=4.00m, T of PCCP=0.23m, Thk 201=0.20, SHOULDER: Width BS=0.50m, Grouted Riprap Length=28.00m);**

**WHEREAS**, the Provincial Government of Oriental Mindoro thru its Bids and Awards Committee advertised the Notice of Invitation to Bid (IB No. CW-2021-484) in PhilGEPS Website on **November 01, 2021** and posted in the Provincial Capitol Complex, Bulletin Board, Camilmil, Calapan City on even date for the **Concreting of Road at Herrera, Naujan, Oriental Mindoro (Concreting of Road: PCCP: L of PCCP=68.00m, W of PCCP=4.00m, T of PCCP=0.23m, Thk 201=0.20, SHOULDER: Width BS=0.50m, Grouted Riprap Length=28.00m);**

**WHEREAS**, in response to the said advertisement, **two (2) prospective bidders/contractors** submitted application for eligibility and purchased bid documents;

- 1. RJJJ ENGINEERING SERVICES**
- 2. TWENTY SIXTEEN CONSTRUCTION & GENERAL MERCHANDISE**

**WHEREAS**, the opening of bid was held at BAC Office, Provincial Capitol Complex, Calapan City on **November 10, 2021**, the bids were received until **8:30 am** and opened thereafter in accordance with the provisions of **R.A. 9184** otherwise known as "**Government Procurement Reform Act and its Implementing Rules and Regulations**";

**WHEREAS**, during the opening of Bid on **November 10, 2021** eligibility check was conducted to two (2) bidders/contractors mentioned above and were found eligible by the BAC;

**WHEREAS**, all bid proposals submitted during the opening of bid were examined and found substantially complied with the technical and financial proposals, thereby making all bid proposals passed the preliminary examination of bid as their corresponding bid price read out as follows.

**WHEREAS**, the detailed evaluation and comparison of bids conducted on **November 10, 2021** found out that bid price of **RJJJ ENGINEERING SERVICES** is deemed the most advantageous to the government and no minor arithmetic correction has been made and therefore, found to be the **Lowest Calculated Bid**;

**WHEREAS**, upon careful examination, validation and verification of eligibility, technical, financial requirements submitted by **RJJJ ENGINEERING SERVICES** with **Lowest Calculated Bid**, its bid passed the post qualification process conducted on **November 12, 2021**, thereby making its bid found to be responsive;
