CONTRACT AGREEMENT

THIS AGREEMENT, made this DEC 03 2021 between PROVINCIAL GOVERNMENT OF ORIENTAL MINDORO, Camilmil, Calapan City, Oriental Mindoro, represented by HUMERLITO A. DOLOR, MPA, Ph.D., Provincial Governor hereinafter called the "ENTITY" and RGDG CONSTRUCTION with office address at 148 Diamond St., Bernabe Subdivision, Phase I, Parañaque City, Metro Manila represented by RIC R. GUMAPAC, Proprietor, hereinafter called the "CONTRACTOR".

WHEREAS, the ENTITY is desirous that the CONTRACTOR execute the Construction of Temporary Stockroom at Sentrong Pangkabataan at Sta. Isabel, Calapan City, Oriental Mindoro, hereinafter called the "WORKS", and the ENTITY has accepted the Bid for the amount SEVEN HUNDRED NINETY SEVEN THOUSAND TWO HUNDRED FORTY TWO PESOS AND 80/100 ONLY (Php 797,242.80) by the CONTRACTOR for the execution and completion of such Works and the remedying of any defects therein.

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:
