## Construction of Temporary Stockroom at Sentrong Pangkabataan at Sta. Isabel, Calapan City, Or. Mindoro

- 1. The Provincial Government of Oriental Mindoro (PGOM) through the SB # 2- General Fund 2021 intends to apply the sum of Seven Hundred Ninety Eight Thousand Three Hundred Thirty Five Pesos and 46/100 Only (Php 798,335.46) being the approved Budget for the Contract (ABC) to payment under the contract for Construction of Temporary Stockroom at Sentrong Pangkabataan at Sta. Isabel, Calapan City, Or. Mindoro". Bids received in excess of the ABC shall be automatically rejected at bid opening.
- 2. The PGOM now invites bids for "Construction of Temporary Stockroom at Sentrong Pangkabataan at Sta. Isabel, Calapan City, Or. Mindoro". Completion of the Works is 39 calendar days. Bidders should have completed within five (5) years before the date of submission and receipt of bids, a single completed contract similar to the Project worth at least fifty percent (50%) of the ABC. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.
