Construction of Temporary Stockroom at Sentrong Pangkabataan at Sta. Isabel, Calapan City, Or. Mindoro

1. The **Provincial Government of Oriental Mindoro (PGOM)** through the **SB # 2- General Fund 2021** intends to apply the sum of **Seven Hundred Ninety Eight Thousand Three Hundred Thirty Five Pesos and 46/100 Only (Php 798,335.46)** being the approved Budget for the Contract (ABC) to payment under the contract for **Construction of Temporary Stockroom at Sentrong Pangkabataan at Sta. Isabel, Calapan City, Or. Mindoro**. Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The PGOM now invites bids for **“Construction of Temporary Stockroom at Sentrong Pangkabataan at Sta. Isabel, Calapan City, Or. Mindoro”**. Completion of the Works is **39 calendar days**. Bidders should have completed within five (5) years before the date of submission and receipt of bids, a single completed contract similar to the Project worth at least fifty percent (50%) of the ABC. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.
