**BAC RESOLUTION DECLARING SINGLE CALCULATED RESPONSIVE BID (SCRB) AND
RECOMMENDING APPROVAL OF AWARD OF THE CONTRACT
(INFRASTRUCTURE)**

WHEREAS, there is an infrastructure project funded through the LGSF-DRRP Fund 2021 to be undertaken by the Provincial Government of Oriental Mindoro for the **Repair of 1 CL in Calingag ES, Pinamalayan, Oriental Mindoro and Improvement of Day Care Center at Bangbang, Pinamalayan, Oriental Mindoro (Repair of Roofing of 1 Classroom/Extension of 3.7m x 6.4m Day Care Center(Feeding Area) Embankment of 0.30m and 0.10m for Flooring, Plumbing for Wash Area, Installation of 2pcs 9watts Led Bulb. Painting Works Includes Repainting of Existing Day Care and Extension);**

WHEREAS, the Provincial Government of Oriental Mindoro thru its Bids and Awards Committee advertised the Notice of Invitation to Bid (IB No. CW-2021-487) in PhilGEPS Website on **November 01, 2021** and posted in the Provincial Capitol Complex, Bulletin Board, Camilmil, Calapan City on even date for the **Repair of 1 CL in Calingag ES, Pinamalayan, Oriental Mindoro and Improvement of Day Care Center at Bangbang, Pinamalayan, Oriental Mindoro (Repair of Roofing of 1 Classroom/Extension of 3.7m x 6.4m Day Care Center(Feeding Area) Embankment of 0.30m and 0.10m for Flooring, Plumbing for Wash Area, Installation of 2pcs 9watts Led Bulb. Painting Works Includes Repainting of Existing Day Care and Extension);**

WHEREAS, in response to the said advertisement, **one (1) prospective bidder/contractor** submitted application for eligibility and purchased bid documents;

1. SOSEP BUILDERS

WHEREAS, the opening of bid was held at BAC Office, Provincial Capitol Complex, Calapan City on **November 10, 2021**, the bids were received until **8:30 am** and opened thereafter in accordance with the provisions of **R.A. 9184** otherwise known as "**Government Procurement Reform Act and its Implementing Rules and Regulations**";

WHEREAS, during the opening of Bid on **November 10, 2021** eligibility check was conducted to one bidder/contractor mentioned above and were found eligible by the BAC;

WHEREAS, the bid proposals submitted by **SOSEP BUILDERS** was examined and found substantially complied with the technical and financial proposals, thereby making the bid proposals passed the preliminary examination of bid as the bid price read out as:

WHEREAS, the detailed evaluation of bids conducted on **November 10, 2021** found out that bid price of **SOSEP BUILDERS** is deemed the most advantageous to the government and no minor arithmetic correction has been made and therefore, found to be the **Single Calculated Bid**;
