CONTRACT AGREEMENT

THIS AGREEMENT, made this DEC 02 2021 between PROVINCIAL GOVERNMENT OF ORIENTAL MINDORO, Camilmil, Calapan City, Oriental Mindoro, represented by HUMERLITO A. DOLOR, MPA, Ph.D., Provincial Governor hereinafter called the "ENTITY" and SOSEP BUILDERS with office address at Campaasan, Bulalacao, Oriental Mindoro represented by ENGR. ERNESTO C. VILLAS, JR., Proprietor, hereinafter called the "CONTRACTOR".

WHEREAS, the ENTITY is desirous that the CONTRACTOR execute the Repair of 1 CL in Calingag ES, Pinamalayan, Oriental Mindoro and Improvement of Day Care Center at Bangbang, Pinamalayan, Oriental Mindoro, hereinafter called the "WORKS", and the ENTITY has accepted the Bid for the amount FIVE HUNDRED NINETY SIX THOUSAND EIGHT HUNDRED FIFTY SIX PESOS AND 80/100 ONLY (Php 596,856.80) by the CONTRACTOR for the execution and completion of such Works and the remedying of any defects therein.

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:
